During a public health event, such as the COVID-19 pandemic, medical, legal, and economic conditions are subject to abrupt change at any time. ECF will undertake its best efforts to prevent the spread of communicable diseases within the school, and by enrolling your child with ECF you agree to partner with us in our commitment to safety, by following our policies and procedures. Nonetheless, because attendance at school requires physical interaction, ECF cannot guarantee that communicable illnesses or pathogens, including COVID-19, will not enter the school. By enrolling your child, you acknowledge and agree that ECF may take risk mitigation steps such as testing (e.g., temperature checks), sending children home, limiting physical contact between students and faculty, transitioning to remote learning, or other precautions. By doing so, it does not assume any responsibilities beyond legally applicable standards.

Because of health or other safety concerns, ECF may institute remote learning for a period of time as warranted by the circumstances. In the event that remote learning is required for a week or more, at the end of the semester ECF will rebate 2% of your child's full tuition for each week that the school's physical facility is closed to students, up to a total of 20% of the total tuition amount.
